## **Environmental Policy**

2.1. The Company places importance on water resources management in order to reduce risks of shortage, with an effective wastewater management system in place.

2.2. The Company is committed to fostering awareness among all its employees regarding the importance of water resources and water saving.

#### 3. Trash, Waste, and Pollution Management

The Company always recognizes the significance of trash, waste, and pollution management, adhering to the principles of resources usage to their utmost benefit. The related practice of 3R (Reduce, Reuse, Recycle) is adopted, bringing back materials and refuse to the cycle of use throughout the supply chain according to these measures:

Where the creation of waste cannot be avoided, the Company manages each type of waste based on its potential of use, minimizing the amount of waste being sent for disposal by burial at landfills.

3.2. The Company manages its industrial waste in the category of waste from the production process which cannot be recycled by focusing on compliance with regulations whereby waste would not affect the environment. Disposal measures are in place which is strictly in accordance with the law and the guidelines of industrial plants, with waste segregation system based on category to be disposed of correctly with its standards.

3.3. The Company gives emphasis on the monitoring of air pollution, strictly following the law to promote health, occupational hygiene, and safety of the workplace environment. This is also to reduce the impact on the environment, since the Company recognizes that pollution can be caused by its production and spread into nearby communities. Therefore, the Company is ever ready to determine measures with the community to prevent pollution that might be released into the outside of communities. The Company also allows the communities to file any complaints or report issues caused by the Company's operations which may cause environmental issues.

3.4. The Company evaluates its factory performance of waste management to find root causes and shortcomings which may be the reason waste management in the factories is still not efficient or not reaching goals. Improvements and development of waste management activities are continuously done following the principles of 3R.
